To address this shortfall, I see a need for all surveying associations across Australia to increase support for organisations like A Life Without Limits, Destination Spatial and NSW Surveying Taskforce to assist them in raising our profile in schools and the community hopefully increase surveying enrolment numbers back to where they need.

Finally, after 10 years as a director and the last 4 years as president I am stepping down from both roles. It has been a privilege and an honour to serve on a board where everyone's sole objective has been the advancement of AIMS and would like to thank everyone who served as executives and directors during that time. Their dedication and time taken to the promotion of our industry continues to make AIMS the leading Mine Surveying organisation in Australia.
